# PART 1 - GENERAL INFORMATION

#### 1. **Security Requirement**

There is no security requirement associated with the requirement.

#### 2. Requirement

The Royal Canadian Mounted Police (RCMP) has a requirement for a firm quantity of four hundred ninety-five (495) Jackets, Blue, All Ranks, Male and seventy-five (75) Jackets, Blue, All Ranks, Female.

There is an optional quantity of up to two hundred (200) Jackets, Blue, All Ranks, Male & Female which can be exercised within 24 months of contract award.

There is also an "as and when requested" quantity of up to fifty (50) Jackets, Blue, All Ranks, Male & Female (Flexible Stock) which can be ordered within 24 months of contract award.

This requirement also includes an "as and when requested" quantity of up to thirty (30) made-tomeasure Jackets, Blue, All Ranks, Male (Specials) and an "as and when requested" quantity of up to ten (10) made-to-measure Jackets, Blue, All Ranks, Female (Specials). Made-to-measure quantities can be ordered within 36 months of contract award.

This requirement is conditionally limited to Canadian goods.

#### 2.1 **Optional Quantities**

The Contractor grants to Canada the irrevocable option to purchase Jackets, Blue, All Ranks, Male & Female under the same terms and conditions and at the price(s) in the resulting contract. The optional quantity may only be exercised for up to a maximum of two hundred (200) units. The optional quantity may only be exercised by the Contracting Authority and will be evidenced, for administrative purposes only, through a contract amendment.

The Contracting Authority may exercise the optional quantity within 24 months after contract award date by sending a written notice to the contractor.

#### 3. Debriefings

After contract award, bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days of receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

The 2003 (2013-06-01) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

# 2. Submission of Bids

All enquiries must be submitted in writing to the Contracting Authority no later than **seven (7)** calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the questions or may request that the Bidder do so, so that the proprietary nature of the question is eliminated, and the enquiry can be answered with copies to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

# 4. Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in the province of Ontario.



# PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

#### 1. Evaluation Procedures

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.
- (c) The evaluation team will determine first if there are two (2) or more bids with a valid Canadian Content certification. In that event, the evaluation process will be limited to the bids with the certification; otherwise, all bids will be evaluated. If some of the bids with a valid certification are declared non-responsive, or are withdrawn, and less than two





responsive bids with a valid certification remain, the evaluation will continue among those bids with a valid certification. If all bids with a valid certification are subsequently declared non-responsive, or are withdrawn, then all the other bids received will be evaluated.

However, only one deviation will result in the bid being declared non-responsive.


