AMENDMENT #1

This amendment is raised to answer questions submitted by a supplier

Question:

In Annex A - Statement of Work - point 11, it states a maximum of 13 hours of work per week. I assume that is per institution. Kent and Mountain currently have 14 hours of work per week (4 - 3.5 hour sessions), which already exceeds the maximum allowed. Is this correct?

Also, the total hours for Kent are only 645 which doesn't allow for a methadone clinic each week. Is there any way to change that before the bid is submitted?

Answer:

The SOW point 11.1 states a maximum of 13 hours per week, but not all institutions will be using the maximum number of hours. Kent has allowed for 10.5 hours a week. The 645 total hours are distributed as follows:

- 546 hours for medical sessions
- 91 hours for methadone sessions
- 8 hours for meetings
