PART 1 - GENERAL INFORMATION

1. **Security Requirement**

There is no security requirement associated with the requirement.

2. Requirement

The Royal Canadian Mounted Police (RCMP) has a requirement for a firm quantity of one hundred and fifty-five (155) Sam Browne, Officer's Belts and three hundred (300) Sam Browne, Officer's X-Straps.

In addition, there is an "as and when requested" quantity of up to ten (10) made-to-measure Sam Browne, Officer's Belts (Specials) and an "as and when requested" quantity of up to ten (10) made-to-measure Sam Brown, Officer's X-Straps (Specials). Specials can be ordered within 36 months of contract award.

There is also an "as and when requested" quantity of up to thirty (30) Sam Browne, Officer's Belts (Flexible Stock) and an "as and when requested" quantity of up to one hundred and fifty (150) Sam Browne, Officer's X-Straps (Flexible Stock), which can be ordered within 36 months of contract award.

Also, there are 2 optional quantities for up to a maximum of 50 Sam Browne, Officer's Belts each. The first option can be exercised within 12 months of contract award and the second option can be exercised within 24 months of contract award.

The requirement is to be supplied in accordance with RCMP Specification G.S. 1045-145 dated 2014-04-08 and viewing sample.

This requirement is conditionally limited to Canadian goods.

2.1 **Optional Quantities**

The Contractor grants to Canada two irrevocable options to acquire Sam Browne, Officer's Belts under the same terms and conditions and at the price(s) in the resulting contract. The optional quantities may only be exercised for up to a maximum of fifty (50) units each. The optional quantities may only be exercised by the Contracting Authority and will be evidenced, for administrative purposes only, through a contract amendment.

The Contracting Authority may exercise the first optional within 12 months after contract award date and the second optional quantity within 24 months of contract award date, by sending a written notice to the contractor.

3. Debriefings

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The 2003 (2013-06-01) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

2. Submission of Bids

Bids must be submitted only to Royal Canadian Mounted Police (RCMP) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

Due to the nature of the bid solicitation, bids transmitted by facsimile or by email to the RCMP will not be accepted.

<u>PLEASE NOTE</u>: Bidders may submit more than one (1) bid per solicitation; however multiple bids must be submitted in separate bid packages.

3. Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than seven (7) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the questions or may request that the Bidder do so, so that the proprietary nature of the question is eliminated, and the enquiry can be answered with copies to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

4. Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in the province of Ontario.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that bidders follow the format instructions described below in the preparation of their bid:

- (b) use a numbering system that corresponds to the bid solicitation.

To assist Canada in reaching its objectives, bidders should:

PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

1. **Evaluation Procedures**

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.
- (c) The evaluation team will determine first if there are two (2) or more bids with a valid Canadian Content certification. In that event, the evaluation process will be limited to the bids with the certification: otherwise, all bids will be evaluated. If some of the bids with a valid certification are declared non-responsive, or are withdrawn, and less than three responsive bids with a valid certification remain, the evaluation will continue among those bids with a valid certification. If all bids with a valid certification are subsequently declared non-responsive, or are withdrawn, then all the other bids received will be evaluated.

1.1 **Technical Evaluation**

1.1.1 **Mandatory Technical Criteria**

As part of the technical evaluation, to confirm a Bidder's capability of meeting the technical requirements, one (1) pre-award sample of each of the following items will be required:

The Bidder must ensure that the required pre-award samples are manufactured in accordance with the technical requirement and are fully representative of the bid submitted. Rejection of the pre-award samples will result in the bid being declared non-responsive.

An RCMP viewing sample will be provided to bidders who are requested to provide pre-award samples and is to be used for guidance for all factors not covered by the RCMP specification. The RCMP specification shall govern.

The viewing sample is not to be damaged or cut, but returned in the same condition as sent to the bidder.

The bidders must deliver the required pre-award samples and certificates of compliance at no charge to Canada and must ensure that they are received within **45 calendar days** from request. The pre-award samples will be evaluated for quality of workmanship and conformance to specified materials and measurements. Minor observations will not be a reason to reject the sample(s) unless, in the opinion of the technical evaluator(s), they are considered to render the item unserviceable. However, only one deviation will result in the bid being declared non-responsive.

The requirement for pre-award samples and certificates of compliance will not relieve the successful bidder from submitting sample(s) and certificates of compliance as required by the contract terms or from strictly adhering to the technical requirement of this Request for Proposal and any resultant contract.

Certificate of Compliance - Definition

A certificate of compliance is defined for this solicitation as a signed and dated certification by an appropriate official of the component manufacturer (e.g. slide fastener, hook and loop, webbing, etc.). It must specifically address the adherence of the offered component to the specification or manufacturing data of the technical requirement.

A separate certificate of compliance is required for each individual product or component. It must be dated within eighteen (18) months of the solicitation posting date; and must certify that the product for which the Certificate of Compliance was issued is the same product used in the bid submission, or in the pre-award samples or in the pre-production samples, or in the production units as applicable.

1.2 Financial Evaluation

2. Basis of Selection






