The objective of amendment 004 is to provide bidders with questions/answers 26 and 27.

Included in this solicitation amendment:

1. Questions and answers

Question 26)

Is it possible to get additional information regarding the seafloor characterization?

Answer 26)

Please note that the analysis results of the seafloor characterization conducted in 2011-2012 are now available for download from the buyandsell.gc.ca website.

Also, please consider the following information:

- During dredging operations:
 - Vertical segregation is permitted but it is not mandatory;
 - Horizontal segregation is required to separately manage the sediment from polygon A
 - Horizontal segregation is required to separately manage sediments with different levels of contamination relative to the Soil Protection and Contaminated Sites Rehabilitation Policy of MDDELCC and the Regulations respecting the burial of contaminated soil (RESC): it is possible that some polygons need to be subdivided to segregate the dredged material affected by different levels of contamination.
- The Contractor is responsible for determining the contamination distribution levels for the contractual dredging volumes according to the best practices accepted by the MDDELCC. The volume and the sediments contamination level from overdredging should not be considered in the calculation of the distribution of the different contamination levels, since no dilution is permitted.
- The Contractor shall prepare and include in its dredging program of work (and if necessary, at the request of the Authorization Certificate), a drawing showing the contamination levels distribution of sediment in place according to the soils generic criteria of the Soil Protection and Contaminated Sites Rehabilitation Policy of MDDELCC and the Regulations respecting the burial of contaminated soil (RESC), and a table summarizing the distribution of volumes with different levels of contamination for each polygon A to L. the Contractor is responsible for obtaining MDDELCC authorizations and shall, if required to obtain the certificate of authorization and at its own expense, make the necessary adjustments to its work program.
- The Contractor shall ensure the final management of the dredging material based on the contamination levels distribution of the sediment in place, unless the dredging material will undergo treatment in order to reduce the concentration of Cu and/or PAHs. In case where the dredging material will undergo such treatment, it should be characterized (before and after treatment) to determine the mode of final management. The characterization, before and after treatment, will also demonstrate the efficiency of the treatment. The Contractor shall comply with the specific requirements that may be requested by the MDDELCC.
