R.068591.001 – Eastport Road Reconstruction, Terra Nova National Park, NL

**THE FOLLOWING AMENDMENT TO THE BID DOCUMENTS IS EFFECTIVE IMMEDIATELY. THE
ADDENDUM SHALL FORM A PART OF THE CONTRACT DOCUMENTS.**

The tender drawings and unit price table shall be amended and new references added and/or revised to become part of the contract documents as follows:

Queries/Responses:

Query 1: “Item #13 – Install Pipe Sub-drain lists 200mm pipe; however, it is not listed in the supply (item #12). Is it assumed the 200mm pipe will be supplied by PWGSC?”

Response 1: Pipe will be supplied by the Crown. It will be stockpiled at Big Brook Pit in Terra Nova National Park as specified in Section 33 42 13 Clause 1.3.5. The value of the pipe supplied by the Crown is \$6,000.

Query 2: “Item #13 Specification Reference is listed as 32 17 23 (Pavement Marking). Should this be 33 42 13 (same as Pipe Culverts)?”

Response 2: Should read Section 33 42 13 (same as Pipe Culverts).

Query 3: “Also, I cannot seem to find where the 200mm pipe is to be used. The drawings show the 600mm and 900mm, but no 200mm?”

Response 3: 200mm pipe is to be installed in sub-excavation areas: STA 0+460, STA 1+000, STA 3+700, STA 4+000, STA 4+230 and STA 8+160, 50m of pipe at each station.

Query 4: “Lastly, (I believe this may be just a simple typo) on drawing no. C-10 at STA. 8+010 the “NEW” culvert dimensions on the PLAN view differ from the PROFILE view?”

Response 4: It is a typo. Culvert is 900mm.
