SOLICITATION AMENDMENT No. 003

This solicitation amendment No. 003 is raised to:

- 1) publish questions and answers that have been received in relation to this solicitation; and
- 2) amend the solicitation.

1) The following Questions and Answers have been provided:

QUESTION 1:

"With regard to: bid #W00113-13CS49/A annex D; 2.1; R 4 "Teaching experience not related to the health care profession", I am requesting that R4 be opened to all valid teaching experiences."

ANSWER 1:

R4 will not be opened to all teaching. Requirement R4 asks for teaching in an institute that has been accredited by the Canadian Information Centre for International Credentials (CICIC) or the Canadian Medical Association (CMA) to ensure that the level and standard of teaching is within the client's criteria.

QUESTION 2:

"Can you please clarify the difference between Annex D 2.1 Physician Instructor R4 - 1 point for each teaching subject matter that is not related to the healthcare profession, up to a maximum of five points and the next paragraph, 1 point for each teaching subject matter in an institution recognized by the CICIC and accredited by the CMA, to a maximum of 10 points?"

ANSWER 2:

The scoring method allows for the awarding of points for teaching subject matter outside of the healthcare profession and the other allows for the awarding of points for teaching subject matter in an institution recognized by the CICIC and accredited by the CMA.

- 2) At **Part 4 – Evaluation Procedures and Basis of Selection**, Article 4.1(c), of the solicitation "**Evaluation Procedures**",

Delete: Article 4.1(c), in its entirety.

- 2a) At **Part 6 - Resulting Contract Clauses**, Article 6.14, of the solicitation "**Specific Person**",

Delete: Part 6, Article 6.14, in its entirety, and

Insert: **Specific Person(s)**
