

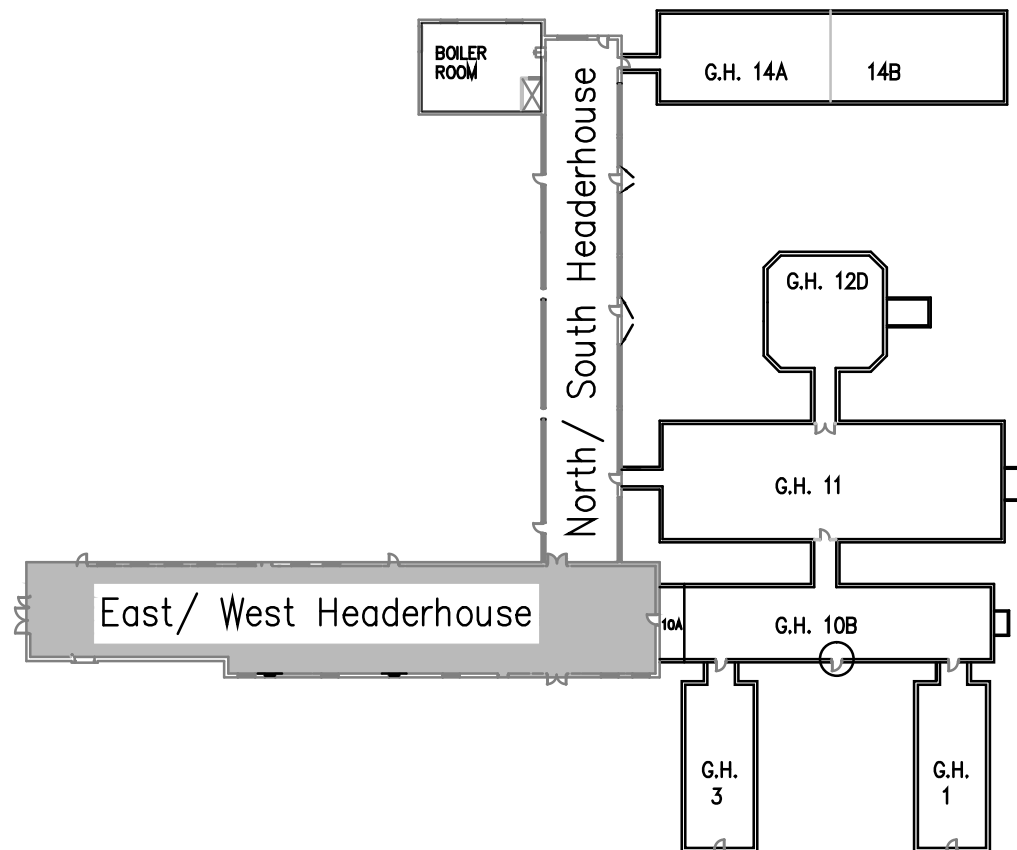

- A. DISMANTLE AND RE-BUILD ALL BRICK AS INDICATED ON DRAWINGS.
- B. REMOVE AND RE-INSTALL ANY SIGNAGE
- C. COVER AND PROTECT LIGHT FIXTURE (TYP)
- D. DISMANTLE TEMPORARY WALL PARTITIONS, INFILL WITH NEW BRICK
- E. REMOVE ALL BLUE SKIN INDICATED ON DRAWINGS
- F. ELECTRICAL TO BE REMOVED & REINSTATED BY OTHERS
- G. SAW-CUT BRICK VENEER, CAULK VERTICAL JOINT AFTER NEW MASONRY HAS BEEN INSTALLED
- H. LOUVER TO BE REMOVED AND REINSTATED AFTER NEW BRICK HAS BEEN INSTALLED
- I. REMOVE EXISTING CAULKING AROUND ALL WINDOW AND DOOR FRAMES.

- 3. PROVIDE BRICK TIES AS PER OBC REQUIREMENTS
- 4. BRICK MORTAR JOINTS SHALL BE (RAKED) TYPE JOINTS
- 5. ANGLE IRONS SHALL BE STAINLESS STEEL
- 6. RE-CAULK ALL WINDOWS / DOORS AFTER ALL MASONRY RESTORATION IS COMPLETE.
- 7. THOROUGHLY CLEAN BRICK FACE TO REMOVE ALL LOSE MORTAR DROPPINGS AFTER TOOLING
- 8. CAULK ALL VERTICAL CUT JOINTS AFTER NEW MASONRY HAS BEEN INSTALLED
- 9. REINSTATEMENT OF ELECTRICAL BY OTHERS

- 1. ALLOW FOR THE DISMANTLING AND REBUILDING OF 2400 SQ.FT (222 m²) OF BRICK

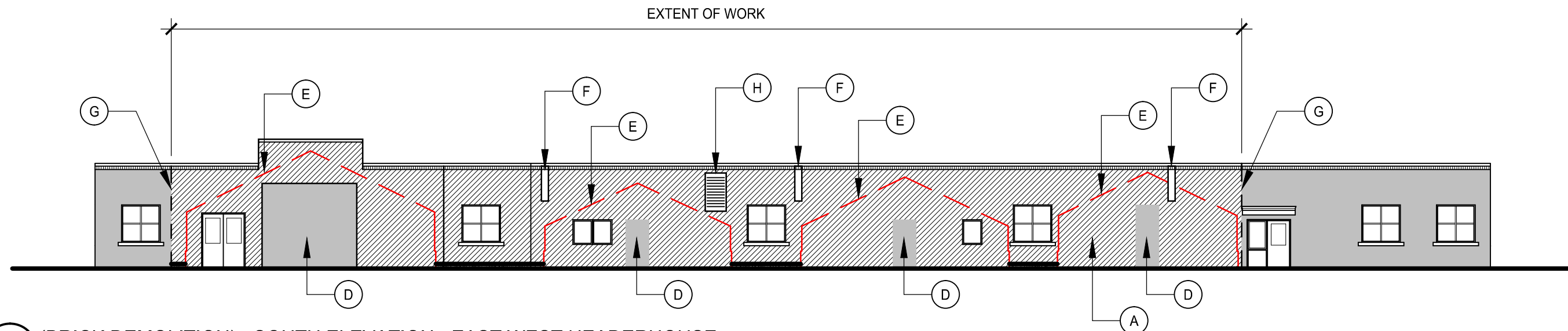
ADDITIONAL REPAIRS FOR PRICING:

ALLOW FOR THE FOLLOWING ADDITIONAL QUANTITIES BEYOND THOSE SHOWN ON ELEVATIONS 1/A300, 2/A300

- 1. ALLOW FOR AN ADDITIONAL 100 SQ.FT (9 m²) OF BRICK REPLACEMENTS.
- 2. ALLOW FOR 42.5m LINEAR METERS (OR 2.5m²) OF BRICK RAKE OUT & REPOINT

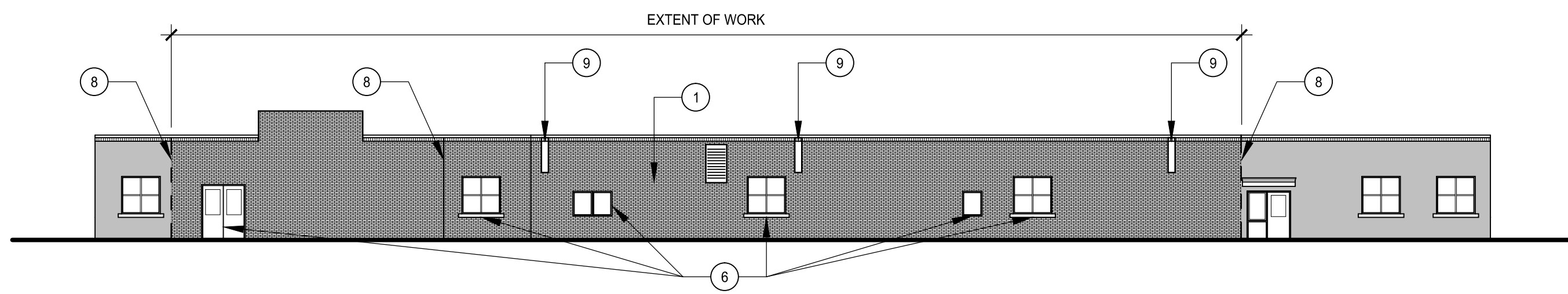

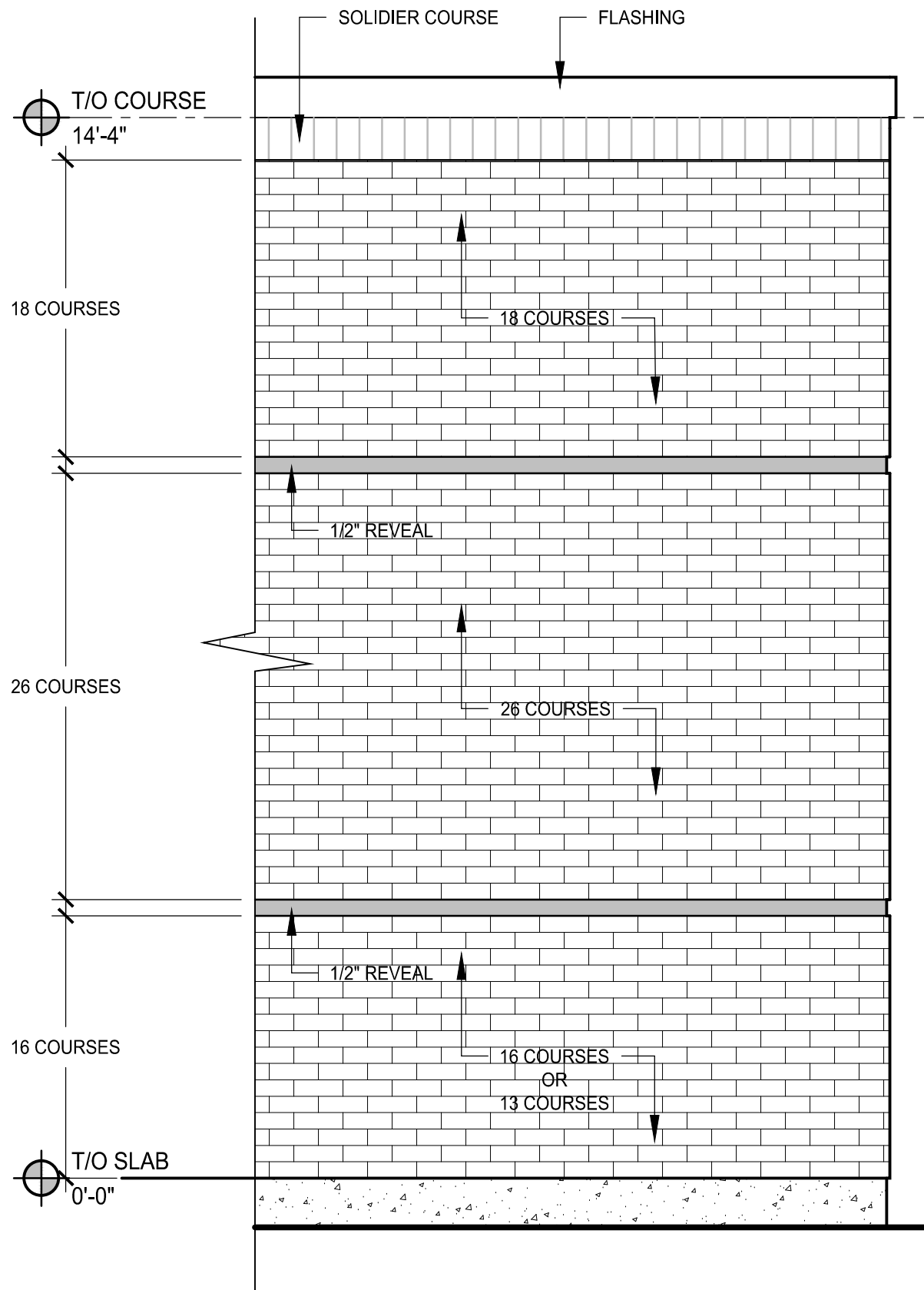

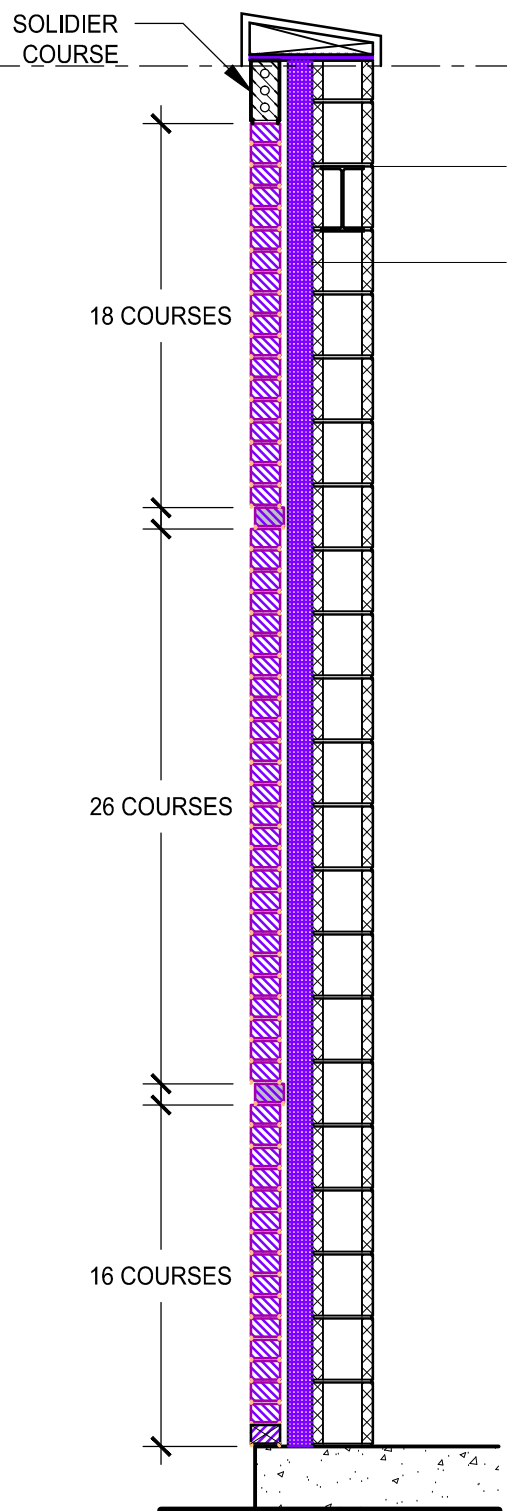

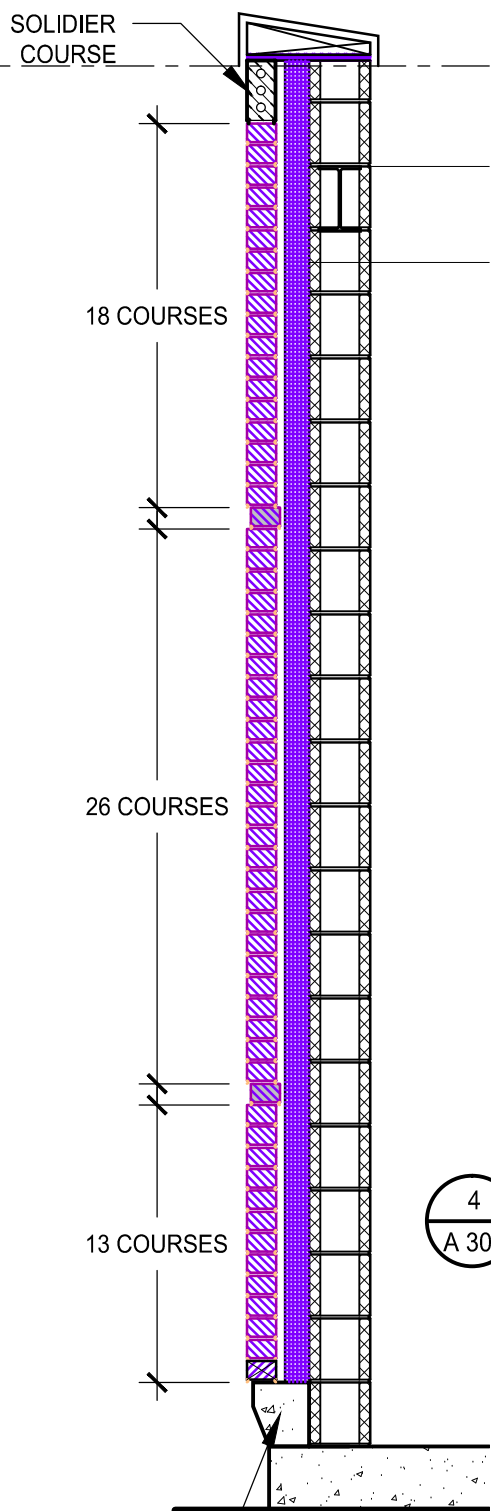

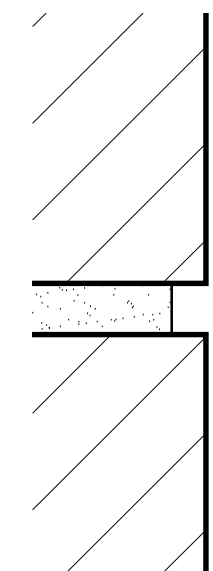
1 ELEVATION BONDING PATTERN
