PART 1 - GENERAL INFORMATION

1.1 Security Requirement

There is no security requirement associated with this bid solicitation.

1.2 Statement of Requirement

2.3 Enquiries - Bid Solicitation

- (a) All enquiries must be submitted in writing to the Contracting Authority no later than ten (10) calendar days before the bid closing date. Enquiries received after that time may not be answered.
- (b) Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

2.4 Applicable Laws

2.5 No Substitute Products

Bidders must provide products that are of the same description, brand name, model and/or part number as detailed in the item description of the bid solicitation. Bidders are advised that substitute products will not be considered.

PART 3 - BID PREPARATION INSTRUCTIONS

3.1 Bid Preparation Instructions

(a) Canada requests that bidders provide their bid in separately bound sections as follows:

- (i) Section I: Technical Bid (4 hard copies)
- (ii) Section II: Financial Bid (1 hard copy)

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

(b) Canada requests that bidders follow the format instructions described below in the preparation of their bid:

4.1 Evaluation Procedures

- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

4.2 Technical Evaluation

(a) Mandatory Technical Evaluation Criteria

The proposed product must meet the mandatory criteria in Annex C - Bid Evaluation Criteria. Failure to meet any one of the mandatory criteria will result in your bid being declared non-responsive.

4.3 Financial Evaluation

(a) Evaluation of Price

- (ii) The evaluated price will be the sum of All-inclusive Firm Lot Prices of the Firm Requirement and the Optional Requirements in Annex B - Basis of Payment.

4.4 Basis of Selection

PART 5 - CERTIFICATIONS

Bidders must provide the required certifications and documentation to be awarded a contract.

- (a) The Contractor must supply and delivery a Yankee Environmental Systems Automatic Total Sky Imager, model TSI-880, that is capable of automated data collection, processing, archiving and presentation of continuous autonomous cloud coverage, and is complete and fully-functional in accordance with the Statement of Requirement at Annex "A".

(b) **Optional Goods and/or Services**

The Contractor grants to Canada the irrevocable option to acquire the goods, services or both described at Annex "B" of the Contract under the same conditions and at the prices and/or rates stated in the Contract. The option(s) may only be exercised by the Contracting Authority and will be evidenced, for administrative purposes only, through a contract amendment.

The Contracting Authority may exercise the option(s) at any time before the expiry of the Contract by sending a written notice to the Contractor.

ANNEX A – STATEMENT OF REQUIREMENT

1. REQUIREMENT

Environment Canada (EC) has a requirement to purchase a Yankee Environmental Systems (YES) Automatic Total Sky Imager, model TSI-880, to automate data collection, processing, archiving and present continuous autonomous cloud coverage.

2. BACKGROUND

EC maintains a network of Brewer Ozone Spectrophotometers which measures the total thickness of the ozone layer several times per hour, when the weather permits. In order to correlate instrument readings to weather conditions, automated cloud monitoring equipment are required to run alongside. Monitoring stations are located at remote sites (for example, Alert, Churchill, Eureka) so equipment must be reliable enough to run unattended for several months at a time.

EC has previously purchased YES TSI-880 Automatic Total Sky Imager units. Additional units are required, over the next couple of years, to be distributed into several remote areas. All units must be in comparison between themselves. Simultaneous data collection and identical approach in data and image processing is crucial therefore models, calibrations and specifications must be identical to reduce variables and allow EC to see results from all units thousands of miles from each other.

3. SPECIFICATIONS

The Contractor must supply and deliver a fully functional TSI-880 Automatic Total Sky Imager to automatically photograph and analyze cloud cover for an extended period of time. At a minimum, the unit must meet the following specifications.

1. Must be compatible with the YES DAQ (data acquisition) software.
2. Must have a built-in HTTP host accessible from remote locations.
3. Must photograph the entire sky at user-selectable intervals. On-board storage should buffer at least two days of data for interval set at one minute.
4. Must store and process the images to create thin/opaque cloud profiles on-board the instrument. Raw images must be in 24-bit colour JPEG format, and the processed output images must be PNG.
5. Must be able to create animations of cloud movement and panoramic views around the instrument.
6. Must connect to an ethernet-based network with built-in cable (RJ-45 10/100BaseT connector).
7. Must have thermostatically-controlled heated optics to prevent freezing and misting.
8. Must be rated to function at temperatures from -40°C to +40°C.
9. Must have a power requirement of 120V 60Hz.
