The below Q and A's are in regards to Annex A of the RFSO.

Q 1. Are ALL business cards for this RFP following the same template as shown on page 25 of the RFP and below?

A1. Yes, all cards follow the same format.

Q2. Will every order be for 2-sided bilingual business cards?

A2. Yes all cards are bilingual 2 sided

Q3. How many business cards orders were placed by these users in 2013?

A3. It is very difficult to determine annual usage as much of the production was conducted in house and has now been discontinued through the use of this tool . The use of a single Agency tool will give us the data for future. Issues like moving from one location to another such as in the NCR, will demand that most staff who currently have cards will need new (not all staff have cards).

Data on population by Centre is given in the SOR. Beyond that list, it is a guess on usage.
