QUESTIONS AND ANSWERS

Q1 - Is VAC already fulfilling this requirement and if so how?

A1 - VAC has short term contracts in place for similar services in Valcartier & Quebec City to meet the immediate need while this competitive process takes place. These services are not being provided via Contract in Bagotville until the successful completion of this competitive process.

Q2 -Some of the requirements are somewhat difficult to meet, especially when it comes to find physicians in locations such as Courcellette (Canadian Forces Base Valcartier) and Alouette (Canadian Forces Base Bagotville), with experience within at least 2 out of the 4 groups of people (5-Senior Citizens, Veterans, Canadian Forces and RCMP clients) and with 2 out of 5 specialties (3- Musculoskeletal problems, mental health problems, complex/multiple health problems, geriatric health problems and chronic pain):

To what extent would VAC be flexible with these requirements?
Would they consider an application that meets them partially?

A2 - VAC has considered this request and has determined that the proposed individuals must meet the mandatory requirements outlined in the RFP (and any RFP amendments).

Q3 - Would they prefer a family physician meeting the requirements or would they consider an application with several specialists covering the listed specialties?

A3 - The requirement is to have one resource per location that meets the mandatory requirements outlined in the RFP (and any RFP amendments) provide the requested services.
