It is stated: "The Supplier must complete the column of Ceiling Unit Rates, line items 1 - 9 for all five years, in Annex "B" - Basis of Payment in the format as specified, in Canadian dollars, Goods and Services Tax (GST) or Harmonized Sales Tax (HST) excluded from the Ceiling Unit Rates, if applicable". There are only two years of pricing tables provided in this Request for Supply Arrangement (RFSA) and the first is described as the first option year and the second is described as the second option year. Were additional tables to be provided for completion?

Answer to Question 1:

The term of "All five years" was used when the RFSA was first posted. At that time, the total period including all optional periods was for five (5) years.

The RSFA is refreshed every year. When re-posted, the period of the Supply Arrangement reduces. The RFSA E60LM-110015/G and E60LM-110015/H is for a period is for two (2) years instead of five (5) years.
