This amendment is raised to answer questions and correct the Specifications.

Questions

Question 1

What is the jam and brickmould colour?

Answer

Both the inside and outside color for all windows and patio doors is beige.

Question 2

Is replacement of window framing included?

Answer

No window framing repair is not included. Replacement of rotten framing will be addressed via contract amendment if required.

Question 3

Will repair of water damaged drywall around windows be required?

Answer

No repair of water damaged drywall is not included. This will be addressed via contract amendment if required.

Ouestion 4

How will windows and doors be insulated and trimmed?

Answer

The SOW is amended to change window style from PVC brickmould to nail-in flange style with no brickmould. All windows and patios doors are to be insulated, spray foamed and sealed to industry standards. (See amendment below.)

- 4. Sealed units will have a minimum 5 year warranty against failure.
- 5. Setting spacer blocks, Neoprene, Block size to suit glass
- 6. Supply and install primed and painted (grey) 1x4 and 2x6 cedar casing to match existing design around windows and doors

All other terms and conditions remain the same.
