Amendment 001 is raised to incorporate the changes to APPENDIX B - PRICE PROPOSAL FORM and to answer the questions below:

**Question 1:** It would appear that the project limits have several bridges. Are the bridge decks part of the scope or are they external from the project?

**Answer to Question 1:** The bridge decks are not part of this project.

**Question 2:** . On page 2 of the Project Brief, page 2, (h) they are looking at culvert replacement methods. Further in clause (p) they are looking for culvert replacement design. The challenge in pricing this work is that over a 23km length there are a lot of culverts. There is no indication of how many require upgrade/repair/replacement along the corridor. For pricing purposes do we assume all the culverts, some of them or none and deal with them as a change order? It is quite open to interpretation and can lead to quite a range of price quotations.

**Answer to Question 2:** We are asking that all the culverts be verified and that recommendations be given for replacement methods for those that require replacement. We will decide which ones we want replaced and you would design for these replacements.

**Question 3.** Clause SC2.4 discusses requirements for provision of services in both official languages outlined in the Project Brief. The Project Brief is silent on language requirements. Please clarify.

**Answer to Question 3:** In the project brief on page 4, RS 4 states the requirement for bilingual construction documents.

**Question 4 :** On Page 4 of the Project Brief it indicates that we are to provide bilingual construction documents. Are we to provide drawings and specifications in both languages?

**Answer to Question 4:** Yes.

**Question 5:** There are boreholes indicated on the 1981 upgrade drawings. Is this geotechnical information available?

**Answer to Question 5:** The geotechnical information, for the boreholes indicated on the upgrade drawings from 1981, is not available.

**Question 6:** If a proponent opts to use a geotech sub-consultant on our team, is that sub-consultant restricted to only being allowed to be part of our team; or can they be a sub-consultant to other teams as well?
