62	Ref: Bid Solicitation, Annex A, Statement of Requirements, Mandatory Requirement M-14 and Solicitation Amendment 006, Modification Number 3: In reference to M-14, as adjusted based on Amendment No. 6, how will this requirement be evaluated?	The response will be evaluated against the bidders chosen option (1,2,3 or4)—either the bidder meets the specified criteria or they do not. For options 1 or 2, the Bidder must provide customer reference contact information in order to validate the client, number of users, number of documents migrated, and date within the last three years. Options 3 and 4 require proof of existing official software publisher certification. The mandatory will not be met if the software publisher does not have existing certification.
63	Ref: Bid Solicitation, Annex A, Statement of Requirements, Mandatory Requirement M-2: Is there a target naming convention to be observed?	No, there is no target naming convention to be observed.
64	Ref: Bid Solicitation, Annex A, Statement of Requirements, Mandatory Requirement M-3: Would a programmatic interface satisfy this requirement?	If by programmatic you mean non-GUI, yes a programmatic interface would satisfy this requirement.
65	Ref: Bid Solicitation, Annex A, Statement of Requirements, Mandatory Requirement M-3: Would a text-based configuration file satisfy this requirement?	No, a text-based configuration file would not satisfy this requirement as it is not an interface
66	Ref: Bid Solicitation, Annex A, Statement of Requirements, Mandatory Requirement M-9: Will the OpenText Content Server REST Web Services API available? Or will the successful vendor be limited to the SOAP version?	REST Web Services API are not available with Content Server version 10.0. Therefore the successful vendor will be limited to the SOAP version.
67	Ref: Bid Solicitation, Annex A, Statement of Requirements, Mandatory Requirement M-16: The text "The software must work, be complete, and meet the requirements of the bid solicitation." Would imply that all rated requirements are now mandatory. Is this the intent? If not, please explain what is meant 'meet	The statement that "the software must work, be complete, and meet the requirements of the bid solicitation" does not imply that rated requirements are mandatory. The implication is that the software meets the requirements to the extent described in the bid solicitation.

	the requirements of the bid', bearing in mind this in a <u>mandatory</u> requirement.	This means that the software must meet all mandatory requirements, and pass the rated requirements in order to achieve the associated points. This does not mean that the software must meet all rated requirements.

Canada confirms that "all repositories" refers to network file systems (shared drives) and EDRMS repositories only.
69	Ref: Bid Solicitation, Annex A, Statement of Requirements, Rated Requirement R-1: Please explain what would constitute "only iterative differences."	The term iterative refers to the process of managing alterations to documents.
70	Ref: Bid Solicitation, Annex A, Statement of Requirements, Rated Requirement R-1: What defines the difference between an iterative change and a "large" change? Do changes in content order apply? What fraction of the text must change? Does changing the word "accepted" to "rejected" change the meaning of a document?	A large change represents an alteration to the substance of a finalized document as opposed to iterative changes which represents the process of managing alterations to a document whether they be large or small. Changes in content order do apply. The fraction of text that must be changed is yet to be determined. Yes, changing the word "accepted" to "rejected" does change the meaning of a document.
71	Ref: Bid Solicitation, Annex A, Statement of Requirements, Rated Requirement R-2: By "dispose", do you mean "mark for deletion", "mark as disposed", "skip during migration", "destroy", or another definition?	The term disposed means mark the document for deletion. A report should be generated for validation by the client before deletion of the document occurs.
72	Ref: Bid Solicitation, Annex A, Statement of Requirements, Rated Requirement R-4: The Content Server Audit Tables are not available through the OpenText Content Server Web Services API required in M-9. Is an alternate method for writing these records to be provided?	Canada is not prescriptive in the method that should be used for writing these records.
73	Ref: Bid Solicitation, Annex A, Statement of Requirements, Rated Requirement R-8: As modifying the security of files in both filesystems and eDocs requires administrator-level access, can you confirm that such access will be granted?	As a rated requirement, you have to provide conditions which allow you to meet this requirement. The Contractor will have administrator-level access to the systems.
74	Ref: Bid Solicitation, Annex A, Statement of Requirements, Rated Requirement R-10: Does this requirement apply to filesystems, eDocs, or both?	This requirement applies to both filesystems and eDocs.
75	Ref: Bid Solicitation, Section 6.1, Security	The Security Requirements set out in

	Requirement: If our request for security clearance isn't processed by bid closing, what or how do we proceed with the bid?	Section 6.1 of the Bid Solicitation must be met before award of a Contract. It is not mandatory that these requirements be met at bid closing. A bid will not be rejected simply because the Security Requirements have not been met at bid closing.
76	Ref: Solicitation Amendment number 7, Question and Answer number 46 and modification number 1: Can you please clarify what is meant by "Constructed links should point to newly migrated documents within GCDOCS." ? If the links are to be preserved (as per the 1 st sentence of the amended requirement R-5) within the target document what links will be constructed?	Pre-existing document links such as those in EDRM must be preserved when the documents are migrated to GCDOCS—therefore the proposed tool must construct new links in GCDOCS that would replicate or preserve the pre-existing links.
