Answer: Fixtures P1 and P2 are back spud fixtures; however the model numbers have been discontinued. The supply shall be back spud as well. Use American Standard 3351 001 with Delta 1600t6102 for item P1, and use American Standard 6515 001 with Delta 1600T6404 for item P2.
