## **Amendment 7**

### **Coffee & juice w/Dispensers**

This amendment was raised to answer a questions from prospective bidder:

**Question:**

1. If year 2 is left blank on the bid. We will the bid be considered non-compliant and not be considered? Or will you be assigned the highest bid from another supplier and be assessed that way?

**Answer:**

1. If year 2 is left blank on the offer on a 2 year request for standing offer, there would be no way to evaluate this. It would be considered non-compliant due to the fact that the offeror would not be demonstrating how they propose to meet the requirement of a 2 year standing offer as stated in part3, section 1.

Part 4, clause 1.2.2 is intended to be used for individual items. It is not intended to alter the intent of the requirement asking for a 2 year standing offer.

Under Part 4, clause 1.1.1

The supplier **MUST** provide a price for a minimum of 90% of items for each year of the Pricing Basis. Failure to do so will render your bid non-compliant and it will be rejected.
