PART 1 - GENERAL INFORMATION

2. Requirement

The requirement is detailed under Article 2 of the resulting contract clauses.

3. Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days of receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

PART 2 - BIDDER INSTRUCTIONS

1. Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the *[Standard Acquisition Clauses and Conditions Manual](https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual)* (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The [2003 \(2014-09-25\)](#) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

2. Submission of Bids

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

3. Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than ten (10) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that

the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

4. Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the bidders.

Canada requests that bidders provide their bid in separately bound sections as follows:

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that bidders follow the format instructions described below in the preparation of their bid:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to the bid solicitation.

In April 2006, Canada issued a policy directing federal departments and agencies to take the necessary steps to incorporate environmental considerations into the procurement process [Policy on Green Procurement](http://www.tpsgc-pwgsc.gc.ca/ecologisation-greening/achats-procurement/politique-policy-eng.html) (<http://www.tpsgc-pwgsc.gc.ca/ecologisation-greening/achats-procurement/politique-policy-eng.html>). To assist Canada in reaching its objectives, bidders should:

- 1) use 8.5 x 11 inch (216 mm x 279 mm) paper containing fibre certified as originating from a sustainably-managed forest and containing minimum 30% recycled content; and
- 2) use an environmentally-preferable format including black and white printing instead of colour printing, printing double sided/duplex, using staples or clips instead of cerlox, duotangs or binders.

Section I: Technical Bid

In their technical bid, bidders should explain and demonstrate how they propose to meet the requirements and how they will carry out the Work.

Section II: Financial Bid

Bidders must submit their financial bid in accordance with the Basis of Payment. The total amount of Applicable Taxes must be shown separately.

- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

1.1 Technical Evaluation

1.1.1 Technical Criteria

- 1. Each bid must meet the Technical Requirements as outlined in Annex A, Requirement;
- 2. Bidders must clearly address each specification for the proposed goods to demonstrate compliance with the Technical Requirements.

1.2 Financial Evaluation

- 1. Bidders must submit pricing in accordance with Annex B, Basis of Payment, with their bid at bid closing;
- 2. The price used in the evaluation will be based on the unit price multiplied by the usage for a total evaluated price.

2. Basis of Selection - Technical Criteria

A bid must comply with the requirements of the bid solicitation and meet all mandatory technical evaluation criteria to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract.

ANNEX "A"

REQUIREMENT

Background:

Measurement Canada is responsible for ensuring the integrity and accuracy of measurement in the Canadian marketplace. We: develop and administer the laws and requirements governing measurement, evaluate, approve and certify measuring devices, and investigate complaints of suspected inaccurate measurement. This includes measuring devices such as vehicle scales.

Objective:

The purchase of the Weight Cart is to facilitate the inspection (examination) of vehicle scales.

Specification:

The Test Weight cart must exceed the following dimensions:
-no longer than 110", no wider than 102", height to be a maximum of 70"

Design as per specification and manufacture a Heavy Duty Motorized Test Weight Mover to hold a minimum 40 x 500 kg test weights.

The cart must comply with National Institute of Standards and Technology (NIST) Handbook 105-8, www.nist.gov/pml/wmd/upload/105-8.pdf specifications and tolerances for field standard weight carts.

The cart must be capable of safely carrying 40 x 500 kg test standards. The weight restraint area of the cart must be designed so that 4 x 500 kg weights, in one straight row, are lifted in the cart at one time. Standards are lifted into the cart using the Measurement Canada weight truck equipped with an articulated crane and 4 hook spreader bar. The weights are 17 inches square at the bottom and are 18.5 inches tall. The weight of the empty cart must not exceed 2500 kg and must be rounded to a standard calibrated round weight in kg, i.e. 2500 kg, 2400 kg, 2300 kg, etc.

The cart is to be self-powered using a gasoline powered engine with electric start and sufficient horse power to be able to move the fully loaded (22,500kg) cart on and around typical (paved and gravel driving surfaces-scales with ramps) vehicle scale operations.

Hydraulic power steering on two of the non-steering power axle.

Four wheel hydraulic drive system.

Auto brakes when engine is turned off.

Sealable shot ballast tank and sealable hydraulic fluid tank.

Smooth tires.

Hour meter on engine

Folding operator stair assembly
