Q.1 How many copies of our Health and Safety Manual do you require to be submitted

R.1 In M5 it states

“M5.

The Bidder must submit, in its offer, a Health & Safety Plan, or Canadian Certificate of Recognition (COR) or Canadian Registered Safety Plan (RSP).”

In the case your company will be sending a Health & Safety Plan, only one copy is required.

Q.2 Do you require the 1st pages of the tender package, Q&A and Amendments to be sign and submitted

R.2 It is appreciated if you sign the 1st page of the solicitation as well as any amendments to the RFSA and provide with your bid submission.

Q.3 Do you require 3 copies of our training course to be submitted?

R.3 Bidders are not required to submit copies of a training course as part of the evaluation process. Bidders must submit all information requested in “Annex C – Evaluation Criteria.”

Q.4 Are you only accepting hard copies of our proposal, will email suffice?

R.4 Yes, only hard copies of bids will be accepted. No emailed or faxed bids will be accepted under this solicitation process.

Q.5 Can you also clarify what is stream 4 and the related services required (page 6 of 6 of Annex C)?

R.5 A precise description of stream 4 was unintentionally left out of the French Statement of Work (Annex A within the RFSA). It has now been added through this amendment and an extension to the submission deadline has been granted due to the omission.

2) On page 22, "Annex A – Statement of Work", section 7: Detailed Description of Tasks:

7.4 Stream 4: Tower Replacement

Any requirement under stream 4 will require the removal of an old communication tower and installation of a replacement tower. The contractor will be required to dismantle, remove and dispose of the structure and hardware as per the requirement

The contractor must supply and install all hardware as per the requirement. All material required or replaced shall be equal to or better than the original equipment manufacturer (OEM) specifications. Site hardware may include items or devices such as antennas, cabling, site grounding, lightning protection, waveguide, waveguide bridges, fall arrest, anti-climb, beacons, lighting, painting, ice shielding, concrete and parging, cable trays and any other various appurtenances that are part of the communications site.
