Answer 1

It is not acceptable to list all sites on one invoice.

It is okay to list and invoice together all elevators located at same site, and invoice must include the inspection reports.

Question 2

For Treasury Board Occupational Health and Safety Directive

4.1 Installation and Alteration

4.1.1 The safety inspector shall advise the operating authority when his or her inspection of an installation or alteration is complete.

Please confirm 4.1.1 is redundant as this tender is for safety inspections only.

Answer 2

Correct, clause 4.1.1 (Installations and Alteration) does not apply under this contract which is for annual safety inspection only.
