QUESTIONS AND ANSWERS

Question 1

Would you like total maintenance and repair included in the price when it comes to maintenance on the forklift truck? Therefore we would be responsible for maintenance and parts besides wearable's such as load wheels and drive tires, etc. Or would you require our Planned Maintenance incorporated in the price, if it's the planned maintenance what frequency would you prefer? We recommend 3 or 4 times per year depending on the usage.

Answer 1

The RFP does not include maintenance and parts as part of the requirement. The RFP is simply for the purchase of one forklift with the option to purchase additional forklifts.

Question 2

Would this truck be a lease for three years with the option of 2 addition 1 year periods or purchasing the machine with total maintenance or no maintenance?

Answer 2

This RFP is for the purchase of a forklift; it is not for the lease of a forklift. As stated in Answer 1, the requirement does not include maintenance services. The options outlined in article 7.4 OPTIONS, are options to extend the period of the contract and options to purchase additional forklifts during the original contract period or during option periods if exercised by CRA.

Question 3
