Objective

The National Research Council - Automotive and Surface Transportation (NRC-AST) would like to purchase a railcar lifting system to be used throughout the AST Uplands facility located in Ottawa, Ontario, Canada. The current method of using hydraulically controlled jacks placed on shims and stands is quite cumbersome and poses a potential safety risk. The new lifting system will be transportable and configurable for the use of lifting various empty or loaded railcars for maintenance purposes.

Requirement Description

The new lifting system must be comprised of four mobile lifting jacks with the following mandatory requirements and accessories:

1. Minimum 100 Ton lifting capacity per cylinder;
2. Minimum 16", maximum 24" stroke;
3. Maximum collapsed height of 31";
4. Electric driven hydraulic pumps – The hydraulic pumps needed to operate the hydraulic jacks must be an electric driven pump only; Air driven hydraulic pumps will not be accepted.
5. Mobile assembly on wheels with ground clearance for transport over rail and rough terrain;
6. Modular design, lifting cylinder must disconnect from wheeled cart;
7. Remote motor control – The electric driven hydraulic pumps must be equipped with remote control to allow remote operation of the pump. On/Off switches must be located on the pump. The length of the remote cable must be at least 15' and no longer than 30';
8. Complete with cylinder extension base and adapters in approximately 4", 8" and 16" sizes, included as accessories;
9. Complete with load holding rings for entire cylinder stroke including additional extensions, included as accessories;
10. Must conform to American Society of Mechanical Engineers standard ASME B30.1-2009 Jacks, Industrial Rollers, Air Casters and Hydraulic Gantries: Safety Standard for Cableways, Cranes, Derricks, Hoists, Hooks, Jacks, and Slings or latest edition.
11. Must provide a drawing with product data and specifications.
