Addendum #1

1) Section – 32 31 13;

.1 Add the following sentence to clause 32 31 13 1.3.5:

Independent testing certification verifying the fences compliance with ICAO frangibility requirements shall also be included in the submittals.

2) Questions received by PWGSC Contracting Oct 14, 2014;

1) Frangible Fencing

We have contacted many different suppliers and have had difficulty finding a fence supplier/ manufacturer that meets the frangibility and radio transparency requirements. Do you have any product names that comply with this specification?

Finding a supplier for the frangible fence is proving to be very difficult. Does the designer have a specific supplier or manufacturer in mind?

Acceptable fence suppliers that are considered to meet the contract specifications include:

- .1 Fibre Net Fibrefence Mesh fencing.
- .2 Exel Composites frangible airport fencing.

2) Additional Question

The fence is 4' high. The drawing does not show barbed wire however the written spec is asking for it. Barbed wire on a 4' high fence is unusual. Please clarify?

The specifications included details for barbed wire as they are comprehensive for any possible fencing needs. The drawings do not show barbed wire as none is required.

3) Additional Question

On drawing C2 it shows where the new proposed fencing will be but in the fencing schedule it shows that there is a lot more. I have attached a the drawing C2 for your review.

The lengths of fence detailed on the drawings are accurate. If the drawings being reviewed are plotted on paper 11" x 17" in size, any measurements from the drawings need to be modified for the change in scale, as the drawings were created to be full sized A1 sheets.
