**Solicitation Amendment No. 002****Title: Insect Repellent**

*This solicitation is hereby amended to provide the following questions and answers:*

**Q4.** Can the mandatory minimum size be changed from minimum 55 ml to a minimum 50 ml?

**A4. YES. The mandatory minimum size is now changed to a 50ml bottle.**

**Q5.** Will DND also accept a bottle with a pump spray?

**A5. NO.** DND will not accept a bottle with a pump spray. Pump spray devices could break away from the bottle within field training which the repellent container will have to endure.

**Q6.** Would DND also accept a 30% Deet repellent with Ethanol instead of Isopropanol?

**A6. Yes DND will accept this only if the supplier can confirm that the replacement of Isopropanol with Ethanol does NOT degrade the effectiveness of the repellent. Descriptive literature with the offered product's specifications must be provided for technical evaluation. This documentation should be submitted with the offer.**
