This amendment is raised to answer the following questions asked by potential bidders:

Question #1 - The following line items have the estimated quantity at "0". Is pricing to be supplied for these items?

- #9 – Beef Liver
- #28 – Pork Creton

Answer #1 – DELETE Item # 9 and #28 from Annex B, Basis of Payment.

Question #2 - Line 13, Hamburger Steakhouse – this product is being discontinued by the manufacturer effective January 1/2015. Is there an alternate that you would like quoted?

Answer #2 – Item 13 is required. As long as we get a 180 gm hamburger meeting the description - Steakhouse or Bear Paw is a suggestion.

Question#3 - Line 19, Pork Ribs – can you please confirm NAMP spec, side or back? Also, does not specify the requested format. Can you confirm pricing should be / kg?

Answer #3 – Item 19 ADD Side, requested format is KG.

Item 20 – ADD back

Question #4 - Line 31, Chicken Quarters – please confirm if breast and leg or only hind quarters (definition not on spec sheet).

Answer #4 – Item 31, ADD breast and leg

Question #5 - Line 41 – Turkey Whole – please confirm sizing (doesn't list on spec sheet).

Answer #5 – ADD turkey sizing 9-11 KG.
