- .4 Add the following note: "From approximate Sta. 0+054 to new well construct surface as per note 14, 3000 wide along C/L."

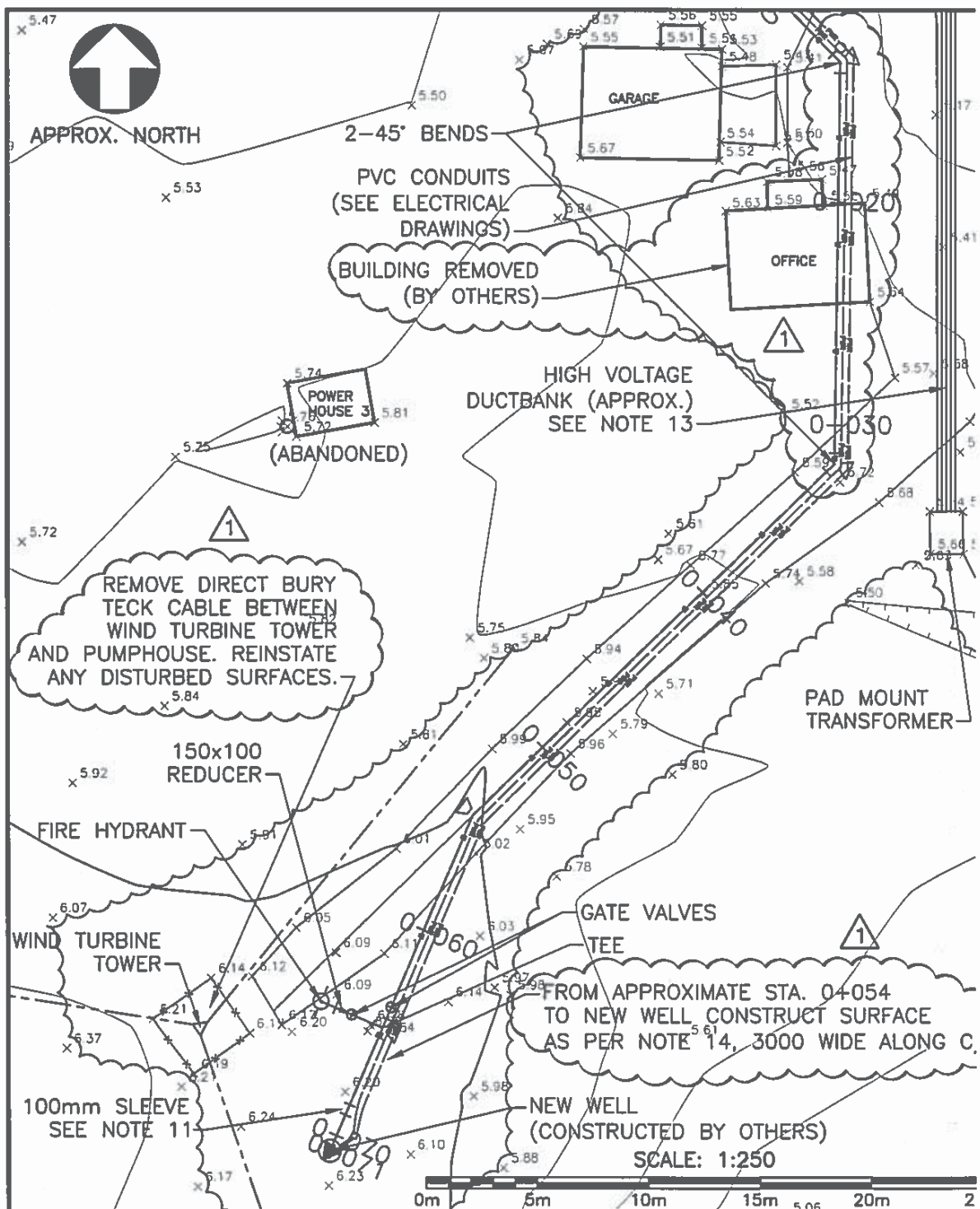
