Part A: Questions from suppliers

Question 1:

In Annex C, what type of "12' Truck Ramps" are to be proposed? Does PCH require a specific type of truck ramp (i.e. for pick-up truck or moving truck)?

Answer 1:

Truck ramps are used for Canada Day on Parliament Hill. They are installed between the stage and dry boxes (53' empty trailer boxes) that are backed up against (or close to) the stage. Those dry boxes are used for storage for all the stage equipment (road cases, band gear, stage set elements, etc.) in order to keep the stage as clear as possible. Ramps should be at least 36 inches wide by 12 feet long with edges to prevent equipment rolling off the sides.


