Solicitation Amendment No. 001

This solicitation is hereby amended to provide the following questions and answers

Q1. Is there currently an incumbent contractor(s) in place or has there been within the last twelve (12) months, providing the same or similar services? If yes, then please provide the name of the incumbent contractor(s) and the contract(s) value.

A1. The incumbent contracting firms, both holding standing offers for similar services, are Valcom Consulting Group Inc. in the amount of \$2,206,798.80 and Procom Consultants Group Ltd. in the amount of \$2,390,699.00.

Q2. RFP Part 7, Resulting Contract Clauses, Item 18 Access to Canada's Property and Facilities states:

Canada's property, facilities, equipment, documentation, and personnel are not automatically available to the Contractor. If the Contractor would like access to any of these, it is responsible for making a request to the Technical Authority. Unless expressly stated in the Contract, Canada has no obligation to provide any of these to the Contractor. If Canada chooses, in its discretion, to make its property, facilities, equipment, documentation or personnel available to the Contractor to perform the Work, Canada may require an adjustment to the Basis of Payment and additional security requirements may apply.

Where are services required by this RFP to be provided (Contractor site vs Canada?)

A2. All contractors will be required to work at 5th Canadian Division Support Base Gagetown, the client's site.

Q3. Would the Department of National Defence (DND) consider having some of the Help Desk Specialists in a location other than CFB Gagetown?

A3. No. All contractors will be required to work at 5th Canadian Division Support Base Gagetown, the client's site.

Q4. Due to the volume of information required, we request a 2 week extension to the current delivery date of November 18, 2014.

A4. The bid closing date has been extended to November 28, 2014.

Q5. Is there someone currently providing these services or has there been someone providing these services? If yes, who has been providing these services, what is the value of the contract(s)?

A5. See Question and Answer 1 above.

Q6. At Annex D on page 2 of 6 (M2.2 for the System Administrator Level 1 resource) there is a mandatory requirement for the resource to be a “Microsoft Certified Systems Administrator (MCSA) or Microsoft Certified Systems Engineer (MCSE) on Windows 2000 or later.” As it is, this is a very restrictive requirement given that other certifications offer similar type of subject matter expertise. In order to open the requirement to these well qualified resources, would the Crown also accept a Microsoft Certified Professional (MCP) on Windows 2000 or later?

A6. Yes, the Crown will accept a Microsoft Certified Professional (MCP) on Windows 2000 or later for the System Administrator Level 1 resource.
