SOLICITATION OF QUALIFICATION (SOQ) / CIC – IIVC 2014

AMENDMENT 001 is raised to:

- **Extend the solicitation period from Monday, November 24, 2014 at 2:00 pm to Monday, December 1, 2014 at 12:00pm; and**
- **Amend article 1.4, Standard Instructions, Clauses and Conditions**

PART 1 - GENERAL INFORMATION & RESPONDENT INSTRUCTIONS

1. Article 1.4 Standard Instructions, Clauses and Conditions is deleted in its entirety and is replaced by:

1.4 Standard Instructions, Clauses and Conditions

- a) Respondents who submit a response agree to be bound by the instructions, clauses and conditions of the SOQ.
- b) Standard Instructions – Competitive Requirements, at Annex “F”, form part of this SOQ, except that:
 - i) Section 03 (4), which discusses a validity period, does not apply, given that this SOQ invites Respondents simply to qualify. Canada will assume that all Respondents who submit a response continue to wish to qualify unless they advise the SOQ Authority that they wish to withdraw their response.

If there is a conflict between the provisions of Annex “F”, Standard Instructions - Competitive Requirements and this document, this document prevails.
