The following is raised to provide clarification in response to questions received and to provide revision concerning the subject Request for Proposal (RFP).

Q1 Are the requested services for the above-referenced solicitation currently being provided or have they been provided previously? If so, please identify the means by which such services have been supplied (e.g. direct and/or term employee(s), personal services contract(s), or contracted services through a company). If the services were contracted through one or more companies or individuals, please provide the name(s) of the contractor(s), the duration and dollar amount of the contract(s).

A1 *Yes, the requested services for the above-referenced solicitation are currently being provided.*

The services are supplied through a Contract to Veritaaq Technology House Inc.

The Contract is for one (1) year plus one (1) one-year option period, which has been exercised. The value of the Contract, option period and Applicable Taxes included, is \$1,693,125.00.

Q4 With regard to Mandatory Requirement M2 (RFP page 2 of 19) and Point Rated Evaluation Criteria R1 (RFP page 10 of 19) for the Application/Software Architect (BI) Level 3, can the Crown please clarify how Bidders can achieve the maximum score for Point Rated Evaluation Criteria R1: as we interpret the scoring for this criteria, are we to assume that the 9+ to 10 years of demonstrated experience required to achieve the maximum points includes both the experience used to substantiate M2 and R1?

A4 *Yes, the 9+ to 10 years of demonstrated experience required to achieve the maximum points includes both the experience used to substantiate **M.2** and **R.1**.*
