Q1: At Annex B, Basis of Payment, in the product description you mention the requirement of Dispensers to be installed however you do not give a number of dispensers required, can you please confirm the type and number of units required?

Annex A, 3.1, the Offeror must provide suitable equipment where required, can you please provide a list of equipment, and the various locations that you mention?

R1: To address both questions, CFB Borden requires 8 dispensers in total (4 dispensers per dishwasher – 2 soap dispensers and 2 rinse dispensers). The equipment must be suitable for a dishwasher and meet the needs of the requirements in Annex A, Requirement and Annex B, Basis of Payment.

Q2: We respectfully ask for permission to visit the sites in order to provide the most comprehensive response.
