1. EXTENSION OF TIME

Notice is hereby given that the time for the reception of tenders previously due December 8, 2014 is hereby extended to 14:00 hours, **December 11, 2014**.

2. QUESTIONS AND ANSWERS

Q1. The clause BA06, Construction time says that the contractor must have completed the dredging before May 30, 2015. Is there any penalties if this is not respected?

A1. Failure to complete the dredging within schedule is considered a breach in the contract. The Contractor and PWGSC may negotiate Extensions of Time based on extraordinary weather or additional work.

Q2. Can you confirm that there will be no additional payment for delays incurred during fishing seasons, weather, during periods when no dredging is permitted. Can you confirm that no compensation will be made for any delays cause by ice condition?

A2. There is no standby being paid for delays for weather, ice conditions, fishing seasons.

Q3. Can you confirm that it's an obligation that the Contractor shall provide, at his expense, a survey vessel for equipment and crew to setup and maintain control for the location of dredge limits and to sound areas, immediately after dredging, to verify that grade depth has been attained.

A3. The Contractor shall provide, at his expense, a survey vessel for the Contractor's surveying equipment, and crew to setup and maintain control for the location of dredge limits, and to sound areas before and after dredging, so as to verify that grade depth has been attained.

- Q4. Can you confirm that no payment will be made to the contractor to remove shoaling or infilling material in dredge areas which occurs prior to acceptance.
- A4. Contractor is paid based on quantity dredged within dredge limits, and then cleared for payment on a daily basis. Dredging of infilled areas may be negotiated and paid under a change order if required.
