**Programmer/Analyst:** The resource will perform programming and application development, the maintenance and upgrades of Drupal 7 core functionality ensuring all deliverables are released to specification, maintained and a guality WCAG 2.0 compliant product is delivered to CMSS clients.

Web Developer: The resources will take MS-Word documents and format content using HTML 5 for posting to the internet site, ensuring all deliverables are to WCAG 2.0 guidelines.

**NOTE:** Bidders may submit a bid for one or all resource categories. However, when submitting resumes, no more than three (3) resumes can be submitted for the Web Developer role and no more than two (2) resumes can be submitted for the Programmer/Analyst role.


