AMENDMENT 002

The purpose of this amendment is to:

A) Respond to bidder's questions:

Question 4: In section M2 you state:

"At least (1) of the projects submitted for evaluation must have been completed where the client, target audience, or subject matter was Inuit."

Our company meets the overall M.2 criteria of showcasing three high-profile projects over 100K(since 2009) that are similar-in-scope, and that have also included sensitive First Nations issues to tell a broader story. All of these were interpretive projects produced specifically for Parks Canada. However, none of these were specifically for an Inuit client, Inuit target audience or featured Inuit subject matter.

Is this need to show 1 Inuit specific project a deal breaker? Even though we are highly qualified, would our company be disqualified for not showing this in the mandatory section?

Answer 4: Please see response to Question 3. Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria. As stated in Part 4 – Evaluation Procedures and Basis of Selection – M.2 Experience of the Firm – Audio-Visual Production Services Projects:

At least one (1) of the projects submitted for evaluation must have been completed:

- Where the client, target audience or subject matter was Inuit.

Failure to provide detailed information for any of the above may result in the proposal being deemed non-responsive. Bids not meeting all the mandatory requirements will be given no further consideration.
