The Request for Proposal (RFP) Amendment 001 is raised to answer Bidders questions and amend the RFP.

Question 1: When is the award date?

Answer 1: Statistics Canada anticipates awarding the contract before 5pm EST on January 2, 2015.

Question 2: Please advise technical definition of single detached "bungalow" as stated in page 11 section M1 of the RFP

Answer 2: We do not have technical definitions of our building models. The role of the contractor hired through this process is to supply us with industry information and advise us of what a suitable technical definition would be for each of the representative building models.

Question 3: Re. Submission of Section I: Technical Bid. Based on our review of the RFP we understand that as part of our submission we are to include information and/or responses to questions on certain pages from the RFP document, for example page 5 of 28 (Former Public Servant in Receipt of a Pension and Work Force Adjustment Directive), pages 11 and 12 of 28, Attachment 1 to Part 4 – Evaluation Criteria (the Mandatory Requirements table), pages 12 to 14 of 28 Attachment 1 to Part 4 – Evaluation Criteria (Point-Rate Criteria table). So we can ensure our response is compliant and easily reviewed we would like to clarify where or how these pages should be included in our submission, for example, should we include at the very beginning the RFP in its entirety with the appropriate sections completed, or immediately after the table of contents, or as an appendices, etc.

Answer 3: The order of the information contained in the bid submission is determined at the discretion of the bidder. All bid submissions will be read thoroughly by the bid evaluation team during the bid evaluation process.

Question 4: Re. Submission of Section II: Financial Bid and Attachment 1 to Part 3 – Pricing Schedule. Are we correct in assuming that our fee submission is to be prepared and submitted on page 9 of 28 of the RFP? Similarly, are we correct in assuming Annex "B" Basis of Payment, page 28 of 28, is part of the contract and is not to be submitted as part of our submission?

Answer 4: The Pricing Schedule must be completed and submitted for Statistics Canada to consider the submission to be complete. You may also include the Basis of payment, but there will not be any penalty if it is omitted from the submission.

Question 5: Point Rated Criteria (Table), PR1 and PR2, Pages 12 and 13 of 28: In each of these requirements it is requested that "At the minimum, the Bidder must describe the details of the completed projects which include a brief description of the projects, including when the work was performed (MM/YY to MM/YY), which residential housing model was included, the client(s), and the approximate size and scope of the projects." Does Statistics Canada wish to have this information duplicated? **Answer 5:** The information provided in the bid submission about completed projects will be used to evaluate the bidder's depth of experience and knowledge with delivering projects of this size.
