AMENDMENT 004

The purpose of this amendment is to:

A) Respond to bidder's questions:

Question 5: The budget maximum stipulated in the RFP is \$125,000. Based on firsthand experience of our crew members who have filmed in the Park in the very recent past, this is a very remote and challenging location to film in, that will require significant use of helicopters, not just for filming but for transporting our crew to the various far-flung regions of the park.

It is also a very dangerous and difficult area to film in, with a constant threat from polar bears and the like. This means having to arrange special escorts for our crew to ensure their safety. Will Parks Canada and the Project Team be providing assistance with either of these (either financially or through using services/contractors that are already under contract to the Park or Project Team)? If not, there will not be enough money left in the budget to produce the kind of film the RFP seems to be asking for.

Answer 5: Filming new footage for this production is not part of the work required to complete this project. As stated in Annex A Statement of Work, Section 8.2, "All footage for this production will be supplied to the Contractor by Parks Canada.

Parks Canada manages a national collection with several hundred hours of HD stock footage, and will provide the Contractor with access to this collection in a managed database format in order to select shots suitable for the production.

Parks Canada and the Contractor shall work together to identify appropriate archival still and moving images and Parks Canada will obtain the rights and releases required to include these images and footage in the production. As required, Parks Canada will source other stock footage of TMNP for the production, in consultation with the Contractor." Section 11.0 (Products and Services) further delineates the responsibilities of the Contractor.

ALL OTHER TERMS AND CONDITIONS OF THE REQUEST FOR PROPOSAL (RFP) REMAIN UNCHANGED.
