The Request for Proposal (RFP) Amendment 003 is raised to answer Bidders questions.

Question 1: On page 7 of the RFP document under Bid Preparation Instructions it mentions:
"Canada requests that bidders provide their bid in separately bound sections as follows:"

Section I: Technical Bid 1 PDF copy via electronic mail.

Section II: Financial Bid 1 PDF copy via electronic mail.

Section III: Certifications 1 PDF copy via electronic mail.

However, directly underneath this it also mentions:

"Canada requests that bidders follow the format instructions described below in the preparation of their bid:"

(a) use 8.5 x 11 inch (216 mm x 279 mm) paper;

(b) use a numbering system that corresponds to the bid solicitation.

The above bid preparation instructions mentions several copies via electronic mail and below in 8.5 x 11 inch paper. Please clarify if this proposal is to be submitted in hard copy by mail or electronic mail.

Answer 1: This proposal is to be submitted by electronic mail. You may also include a hard copy on 8.5 x 11 inch (216mm x 279 mm) paper, but it must be received by the time that the solicitation closes and there will not be any penalty if it is omitted from the submission.
