Part 1. Interpretation

- **1.1** Elections Canada hereby amends in accordance with this amendment the Request for Standing Offer (RFSO) bearing number ECSVT-RFSO-14-0682 and dated December 02, 2014. This amendment hereby forms part of the RFSO.
- 1.2 Unless defined herein or unless the context otherwise requires, all of the words and phrases defined in the RFSO and used in this amendment shall have the same meanings assigned to them in the RFSO.

Part 2. Questions and Answers

The following question has been asked in response to the Request for Standing Offer and Elections Canada hereby answers as follows:

2.1 Question No. 1

Question: Given the amount of information and detail required to properly respond to this RFSO, we do not feel it is possible to adequately respond to this opportunity without additional time being granted. Therefore, again, given the size and complexity of this bid, may we respectfully request that the due date on this bid be extended three weeks?

3.2 Amendment to Section 2.21 – Request for VIC Data Test – of Part 2 of the RFSO

The Request for Standing Offer is hereby amended by deleting sub-section 2.21.1 in its entirety and replacing it with the following sub-section 2.21.1:

2.21.1 No later than January 5, 2015 at 2:00 PM, Offerors wishing to submit on offer shall submit a written request via email to the Standing Offer Authority requesting the VIC data. The VIC data is required to complete a test print run of 200 VICs in accordance with M1 of Part 7 – Technical Evaluation Criteria.
