AMENDMENT 005

The purpose of this amendment is to:

A) Respond to bidder's questions:

Question 6: How will we go about accessing the footage for the project? Do we need to visit a site where the footage is stored or will Parks Canada provide a hard drive(s) - or copy the footage onto one of our drives?

Answer 6: Parks Canada can transfer all the footage onto a hard drive to be provided by the supplier.

Question 7: Has all of the footage been shot or converted into the same format? Or should we budget for the conversion of files? (all of the footage will need to be in a consistent format for off-line editing)

Answer 7: The footage has been shot in multiple digital formats. All are common formats and easily ingested by industry standard software, but it is possible that some frame rate differences may exist.

Question 8: We're very keen on the notion of showing people in the video. Generally, what kind of images can we expect to have access to in this regard?

Answer 8: Much of the footage shows people in the park and most visitors either signed releases or can be contacted to do so.

Question 9: In terms of VO narration, are you opposed to including more than one voice, in the form of VO interviews?

Answer 9: We are open to creative suggestions for all aspects of the production, including the use of more than one voice for the VO narration.
