Question 1 Would it be possible for the bidders get a tour of the storage facility that's available to them for a fee? If not, please provide some details as to what is included in the cost and what is extra? Such as, hydro, heat, dimensions of the building, etc.

Answer 1 There will be an **OPTIONAL SITE VISIT** for the Storage Facility. Bidders are requested to meet at the **Main Gate of Shearwater building Shearwater SH35S (blue building on the left as you enter CFB Shearwater - Base Construction Building) on January 8th, 2015 (Thursday). The site visit will begin at 13:00 AST.** Persons attending should have a valid ID just in case they are asked for it at the secure gate to the airfield.

Bidders are requested to communicate with the Contracting Authority by email or telephone no later than **Tuesday, January 6th, 2015 @ 1200hrs NOON (AST)** to confirm attendance and provide the name(s) of the person(s) who will attend.

Question 2 There was some mention of the two helicopter pads owned by the Department of Fisheries and Oceans onsite. Please advise if the winning bidder/contractor would be responsible for controlling the birds/animals at these two locations?

Answer 2 The winning bidder will be responsible for controlling birds and animals on all areas within the GRA (fenced off area of 12 Wing Aerodrome). The inside of the Coast Guard hangar and J hangar (the semi-permanent structure by pads 2 & 3) are not included in the contract, as they are owned by the Department of Fisheries and Oceans.
