This **amendment #002** is raised to modify Solicitation # 5P404-140635/A and respond to Supplier questions as follows:

-
- Q1** Our 12' long boat ramp pads are made with a 425mm width and 75mm spacing. The spec states a minimum of 350MM in width. Is 425mm acceptable?
- A1** The stated width of 350mm is a minimum. A wider width, such as 425mm, would be acceptable as long as all other dimensions are met: i.e.; 12' long pads and 60, 80', and 52' long ramps.
- Q2** Your specs states that you require enough pads to create two 60" long ramps, two 80' long ramps, and one 52' long ramp along with 31 extra pieces. That being said, with our version of the 12' boat ramp pads being wider, you would only require 235 pieces to complete the same amount of work. Should the quote be for 280 pieces or 235 pieces?
- A2** The replacement pads will be 31 at the minimum dimensions specified, or alternatively the length of approximately 13.2 meters (43.3 feet), whichever is the lowest depending on the product.
- Q3** Are the dimensions stated a "Standard" for the Province of Manitoba or a specific region?
- A3** In this solicitation, Parks Canada Agency is only representing Riding Mountain National Park and cannot confirm if this is a valid specification throughout the entire Province of Manitoba.
- Q4** We currently produce a slightly different size, 3050mm x 350mm x 162mm, and would like to know if this would be an acceptable alternative?
- A4** The existing product on-site is 12 feet long and we cannot reduce this length (Refer to Q&A 1).
- Q5** What exactly are the plastic sleeves for and is there a drawing showing their use, or how they are used? I noticed it also refers to a cable; are we to provide a hole to allow for a cable to run through the slab?
- A5** The plastic sleeve is used to provide access and guidance (entrance and exit through the ramp) and to reduce friction in comparison to just a concrete hole. The cable runs through the entire ramp and is threaded through the plastic sleeve. We do not specify the properties of the plastic sleeve. The solicitation does not call for the provision of cable. We do not have a drawing showing the use of the plastic sleeves. However, the plastic sleeve is used in the industry by various manufacturers of concrete boat ramps.

Delete: Five (5) ramps are required in total. Two ramps will be a length of approximately 18 M (60 FT) each requiring 90 pads. Two (2) ramps will be a length of 20 M (80 FT) each requiring 120 pads and one (1) ramp will be a length of 16 M (52 FT) requiring 39 pads. An additional 31 replacement pads should also be factored in to the total (280) pads.

Insert: Five (5) ramps are required in total. Two ramps will be a length of approximately 18 M (60 FT) each requiring 45 pads (90 pads for both ramps). Two (2) ramps will be a length of 20 M (80 FT) each requiring 60 pads (120 pads for both ramps) and one (1) ramp will be a length of 16 M (52 FT) requiring 39 pads. An additional 31 replacement pads should also be factored in to the total (280) pads.
