This Amendment # 001 to the Request for Proposal is issued to respond to questions received from potential Bidders.

- Q1. CTO 1.1 specifies proprietary SpaceSaver, can we change to technicians showing relevant experience working with SpaceSaver mobile shelving. XXXXXX is a Canadian based company, pioneer in North America, for storage systems, and has relevant experience in converting, moving and upgrading SpaceSaver systems. We think excluding other vendors and sole sourcing would unfairly exclude a Canadian manufacturer while favoring a foreign manufacturer.
- A1. If not certified by Spacesaver to work on Spacesaver products, at least three references from past projects showing that the personnel are qualified will be accepted.
- Q2. Can you exclude the new 77 modules from this contract and into a separate contract. We think that sole sourcing exclusivity to SpaceSaver, again, unfairly favors SpaceSaver and de-facto excludes all other manufacturers from bidding.
- A2. For this project the 77 new modules should be supplied and installed by the same contractor for the following reasons.
- 1- In order to best use the available space at 45 Sacre Coeur the 77 new modules might be needed to compliment multiple sections of different sizes. In other words the 77 new modules will not necessarily all be installed together.
 - 2- Having more than one contractor on the same site becomes problematic, one of the two has to be the General and assume responsibility of the work site.
- Q3. Can we site visit?
- A3. Yes a site visit can be arranged in all three locations.

All other terms and conditions remain the same.
