1) Bidders Questions:

Question 7:

Is the contractor responsible for the electrical connections?

Answer:

Bidder is responsible for electrical work on compressor skid only, all other connections will be done by CanmetENERGY.

Question 8:

The client has requested a soft start. We are looking to offer a dual compressor that has lead lags. Therefore, staggering the start time between compressor blocks. Is this acceptable?

Answer:

Dual compressors will not be accepted due to the increased cost of maintenance and upkeep on two units as opposed to a single unit. Redundant units are not required as operation of system will be intermittent and use of two units to meet flow requirement will require double the maintenance cost and time that would be needed for a single unit that can provide the same capacity.

Question 9:

Please clarify if the vendor is to supply up to 400' of low pressure and high pressure piping or only install and test materials by others?

Answer:

Vendor is responsible for supplying all piping and equipment for installation and testing for both high and low pressure piping.
