AMENDMENT 001

This purpose of this amendment is to modify the testing requirement and answer questions from potential bidders.

Under 4.1.1 Technical Evaluation:

DELETE :

Testing must be performed by an independent accredited laboratory establishment and must be in accordance with the test methods detailed in CAN/CGSB 98.1 - 2011. The laboratory report and test results must be dated after Request for Proposal posting date.

INSERT:

Testing must be performed by an independent accredited laboratory establishment and must be in accordance with the test methods detailed in CAN/CGSB 98.1 - 2011. The laboratory report and test results must be dated within six months of the Request for Proposal posting date.

All other terms and conditions remain the same.

QUESTIONS / ANSWERS

Question 1: Could you please give us more detail information about this item? Because we cannot find any description of the flag's material in the solicitation.

Answer 1: The information is included in the specifications Canadian General Standard Board CAN/CGSB-98.1-2011.

Question 2: As for CGSB Standard, we can't find any information from the CGSB website, how can we get this standard? Please advice.

Answer 2: You need to purchase the specifications from the Canadian General Standard Board. Please refer to paragraph 2.8 Specifications and Standards of the solicitation.

Question 3: As for Part 5 in this solicitation, do you require the certification notarize by any agency?

Answer 3: The information is required for Part 5 – CERTIFICATIONS but it is not required to have it notarize. The information provided will be subject to verification.
