Amendment 002 is raised to answer the following questions:

Question 1: In the Appendix B price proposal form, can traffic control for the geotechnical drilling program and for the field surveying be paid for as a Disbursement in the \$8,695.65 maximum for the geotechnical program in the RS1 to RS2 phase?

Answer to Question 1: Yes, traffic control for geotechnical drilling program and field surveying will be paid a disbursement. Disbursement amounts provided are estimates only – actual disbursements will be reimbursed at cost.

Question 2: In the Appendix B price proposal form, is it by coincidence that the maximum disbursements for the RS3 to RS8 phase is the same amount (\$8,695.65) as the maximum disbursement amount for the RS1 to RS2 phase?

Answer to Question 2: Disbursement amounts provided are estimates only – actual disbursements will be reimbursed at cost.

Question 3: Page 4 of the Project Brief (item 1.3.2.4) states that the consultant is responsible to complete the field layout of the selected alignment. Is this correct, or will this be the successful contractor's responsibility?

Answer to Question 3: delete “field” and Yes, the consultant is responsible for the layout of the selected alignment.

Question 4: Page 24 of the Project Brief requires the Consultant to produce "As-Built Drawings of the existing bridge. Are as-built drawings of the existing bridge actually required, as this bridge is planned for demolition and replacement and not rehabilitation? Is the intent of the as-built drawing to show the existing layout in plain view from information picked up by the consultant's surveyor?

Answer to Question 4: Replace “as-built drawings” with “existing conditions drawings”

Question 5: On page 16, item 6, the table at the bottom of the page refers to an "Environmental Assessment Study and Report" as a Consultant deliverable. On page 26, item 9, Environmental, it is stated that the Consultant is to provide data and information to PWGSC/PCA, for their preparation of an Environmental Assessment of the project. Is page 26 the correct intent for this project?

Answer to Question 5: Clarification- Parks Canada carry out the Environmental Assessment for projects within the Park. The Consultant will be required to provide design information for the proposed work to facilitate the screening and to incorporate the identified mitigation measures into the design and contract documents. Any required studies will be identified during the design/screening process and dealt with as an amendment if necessary.
