Q1: 1-Schedule A - A.6.1.1 Does containers for the DRY MATERIALS recovery are size 2-6 yds or they are the containers 40 yds?

A1-1: sizes are 2, 4, 6, 8 and 40 yd³ (household waste in which can be found dry materials such as waxed cardboard, melamine, plastic ...)

Q1- If they are size 2-6 yds, I understand that they have to be different colors containers for waste. If this is the case is it possible to know the exact number of container for each category.

A1: No, the containers are all the same color.

Q2: Appendix B - B.6.1 You ask that burial certificates are provided with the invoice. What do you mean by burial certificate, is weighing scale voucher confirming the weight of the waste collected or our authorization certificate confirming that we are authorized by the Minister to receive, process and bury the waste?

A2: The burial certificates are required from the company with the following information: weight of the load and the purchase order number to confirm that the items have been buried. In addition, the weighing ticket is required with billing.
