AMENDMENT 003

The purpose of this amendment is to:

A) Respond to bidder's questions:

Question 7: The SRCL (security requirements checklist) provided in Annex C specifies that the contract is UNCLASSIFIED, yet some key personnel will require site-specific security clearances. Can you please specify if these clearances are required before the bid closing date? Or will the bidder provide these names within the specified time frame as indicated in Part 6.1.2?

Answer 7: The SRCL included with the solicitation is hereby withdrawn. The security clauses are hereby revised as indicated in Annex A to this RFP Amendment. Therefore, the Bidder must provide the names of all individuals who will require access to classified or protected information, assets or sensitive work sites with their bid. Within five (5) days of contract award, the successful contractor will be required to provide additional personal information in order to receive the required individual security clearances. Any additional personnel that may require security clearances during the period of the contract, must be pre-approved by the DCH project authority and the DCH Security Officer.

Question 8: We have applied for a Designated Organization Screening (DOS). Must this be finalized before the bid closing date?

Answer 8: No. The Designated Organization Screening (DOS) is no longer a requirement of this procurement.

Question 9: Regarding Section III: Certifications. The Bid Preparation Instruction 3.1 indicates Bidders must provide the certification required under Part 5. In part 5.1 it is explained that the certifications listed may be submitted after bid closing. We were thinking of providing the Annex D to part 5 only with our bid. Would that be sufficient for the time being? Since we are contracting with the Canada government on a regular base, we assume that the Integrity Provisions Associated Information is already available and that we could provide more if required with the eventual contract?

Answer 9: No. As stated in 5.1 Certifications Precedent to Contract Award of the solicitation document, the certifications listed should be completed and submitted with the bid but may be submitted afterwards. If any of these required certifications are not completed and submitted as requested, the Contracting Authority will inform the Bidder of a time frame within which to provide the information. Failure to comply with the request of the Contracting Authority and to provide the certifications within the time frame specified will render the bid non-responsive.

Question 10: Part 6 - Security Requirements, do we need to provide a valid organization security clearance with our proposal as indicated in 6.1 1a?

Answer 10: No. Please see response to Question 8.

Failure to comply with the request of the Contracting Authority and to provide the certifications within the time frame provided will render the bid non-responsive




