#### **SOLICITATION AMENDMENT # 001**

This solicitation amendment is raised to:

- Address the following questions submitted during the solicitation period as per RFP; and
- 2. Amend the RFP.

#### 1. QUESTIONS AND ANSWERS

#### Question 1.

Mandatory Criteria M2 requires that the bidder demonstrate Psychoeducational Assessments were provided in each region. However, the Psychoeducational assessments described in the SOW seem very specific to the CRA.

Will you accept a demonstration of providing similar cognitive assessment as meeting this criteria?

#### Answer 1.

No. The CRA needs to confirm and evaluate the vendors' experience to provide the services as required by CRA. The CRA is looking for a Health Service Provider who has professionals with experience in assessing employees for the purpose of determining their limitations in the context of learning a second language, or in being evaluated for purposes related to a selection process. References for the provision of similar assessments will not be accepted.

#### Question 2.

Can we have an example of the current Psychoeducational Assessment tool that is used?

#### Answer 2.

The Pyschoeducational Assessment may involve a number of different assessments; the content is different depending on what has been deemed necessary by the assessor. The complement of tests used must allow the Service Provider to complete the "Template to be completed when the Service Request pertains to staffing assessments, and/or learning a second official language" as detailed in Appendix I, and provide the employee with a report that includes information responding to the areas indicated on page 90.

The Agency does not have an example of a psychoeducational assessment tool, as employees currently go to physicians in the community to obtain this information as it is required.

### Question 3.

How many hours of testing are currently being done for each Psychoeducational Assessment?

## Answer 3.

The length of the testing will vary depending on the complement of tests used, as well as the individual being assessed, but it is not unusual for the assessment to require 7-10 hours.
