This first (001) solicitation amendment is to answer questions from the industry.

Item 1 – Treadmills

Could we have the speed range altered to 15mph to foster competition and provide you with more alternatives?

We have military members that train for elite level military positions that require to have a treadmill to go at top speeds. With these positions they require to train at elite fitness levels. We would like to maintain the speed requested.

Item 2 - Curved Treadmill

Can we open up this dimension so you can facilitate competition to the Woodway Curve?

We require a longer running surface to accommodate our many different body types. It only makes sense that a bigger frame would provide a bigger running surface. We would like to maintain our original request to provide our clientele with the most operational equipment and options.

Item 3 - Spin Bikes

Can we open this up to chain or belt drive?

We feel chain drive is more realistic to actual riding. Our current bikes are chain driven and we would like to keep the consistency for our members when they use the gym.

Item 9 - Elliptical

Can we get this spec opened up to adjustable or fixed?

In the military we deal with many different clientele body types. There are many different stride lengths due to the different heights of the individuals. We feel the opportunity to work out at different stride lengths greatly benefits our members. Your **gait** changes as you move faster or slow and we would like the machine to adapt to allow that different stride. We request to maintain our original request.

Item 11.1 - Glute/Hamstring Developer

Wouldn't this be better as rubber coated or something? This does not seem to be a suitable spec.?

We would allow the make of the foot pad to be taken out of the requirements. It can be rubber or foam or whatever soft material.

Item 11.2 - Multi-Stack Cable Crossover

Can you provide a schematic of the particular layout you would prefer?

We want the ability to place this machine up against a wall. We would like each end of the cable cross over machine to have three working sides. We would like the back of the machine left open so we can place this next to a wall. This would be a six stack cable cross over machine.
