TITLE: RENTAL VEHICLES IN MIRAMAR, CALIFORNIA

This solicitation amendment is to provide for clarifications regarding the Request for Proposal (RFP).

PART A: QUESTIONS/ANSWERS

Q1 Under Annex "A", paragraph 5 asks for Liability Insurance. Are there any other instructions for this insurance e.g. additional named insured?

A1. The Liability Insurance has been revised.

In Part 2 of 2, Page 5 of 17, under PART 3 - BID PREPARATION INSTRUCTIONS,

DELETE: **Section IV: Insurance Requirements**, in its entirety.

INSERT: **Section IV: Insurance Requirements**

The Offeror must provide a letter from an insurance broker or an insurance company licensed to operate in Canada stating that the Offeror, if issued a standing offer as a result of the request for standing offer, can be insured in accordance with the Insurance Requirements specified in Articles 6.13, 6.14, and 6.15.

If the information is not provided in the offer, the Standing Offer Authority will so inform the Offeror and provide the Offeror with a time frame within which to meet the requirement. Failure to comply with the request of the Standing Offer Authority and meet the requirement within that time period will render the offer non-responsive.

In Part 2 of 2, Page 10 of 17, under **PART 6 - RESULTING CONTRACT CLAUSES**,

DELETE: **6.13 Insurance – Specific Requirements**, in its entirety

INSERT: **6.13 Insurance – Specific Requirements**

The Contractor must comply with the insurance requirements specified in Articles 6.14 and 6.15. The Contractor must maintain the required insurance coverage for the duration of the Contract. Compliance with the insurance requirements does not release the Contractor from or reduce its liability under the Contract.

The Contractor is responsible for deciding if additional insurance coverage is necessary to fulfill its obligation under the Contract and to ensure compliance with any applicable law. Any additional insurance coverage is at the Contractor's expense, and for its own benefit and protection.

The Contractor must forward to the Contracting Authority within ten (10) days after the date of award of the Contract, a Certificate of Insurance evidencing the insurance coverage and confirming that the insurance policy complying with the requirements is in force. For Canadian-based Contractors, coverage must be placed with an Insurer licensed to carry out business in Canada, however, for Foreign-based Contractors, coverage must be placed with an Insurer with an A.M. Best Rating no less than "A-". The Contractor must, if requested by the Contracting

Authority, forward to Canada a certified true copy of all applicable insurance policies.

In Part 2 of 2, Page 10 of 17, under **PART 6 - RESULTING CONTRACT CLAUSES**,

INSERT: 6.15 Automobile Liability Insurance

6.15.1 The Contractor must obtain Automobile Liability Insurance, and maintain it in force throughout the duration of the Contract, in an amount usual for a contract of this nature, but for not less than \$2,000,000 per accident or occurrence.

6.15.2 The policy must include the following:

- a. Third Party Liability - \$2,000,000 Minimum Limit per Accident or Occurrence
- b. Accident Benefits - all jurisdictional statutes
- c. Uninsured Motorist Protection
- d. Notice of Cancellation: The Insurer will endeavour to provide the Contracting Authority thirty (30) days written notice of cancellation.

In Part 2 of 2 / Page 12 of 17, under **ANNEX "A" - REQUIREMENT**

DELETE: 5. **Liability Insurance** in its entirety.

Q2 The way the Annex B - Basis of Payment is arranged makes it difficult to provide an accurate quote. Can Annex B be changed to quote on a daily / weekly / monthly basis? Additionally, it would appear the solicitation is requesting calendar day billing whereas quotes are usually based on a 24 hour cycle. Can you please confirm?

A2. Annex "B" – Basis of Payment has been revised.

Q3. Do the pickup trucks need to be equipped with a hitch?
