Q1. I am writing today in response to the public tender for the two Military Police Ford Interceptors. I am writing to get approval for specific product substitution for the vehicle for the bid. The product meets and/or exceeds requirements set out in this tender. My requests are as follows.

Roof-Mounted Lightbar:

SoundOff Signal nForce 48" Lightbar with Alleys, Forward Take downs and built in traffic direction.

Rear Deck and rear intersection lights

SoundOff Signal nForce Deck/Grille Dual Side-By-Side lights in Red/Blue

Trunk Lights:

SoundOff Signal nForce FIT surface mount.

Push Bumper

Setina PB-450L with SoundOff Signal nForce Lighting in the front and sides. Red/Blue as per requirements.

Siren Controller:

SoundOff Signal Nergy 480 Series Siren. This is the exact same as the 380 series, just the updated model number.

In response to the Military Police Ford Interceptor proposal, I have a product that can be very useful for the Military police when it comes to both Scene and Emergency Lighting.

I have attached information regarding the lights in this email.

The SoundOff Signal nForce Series lighting is the first to market full family of tri-color series emergency lighting. It works in conjunction with the SoundOff Signal nErgy series siren controllers with a computer-based programming software to align siren push buttons to lightbar controls. This allows for minimal installation time as the lightbar plugs directly into the siren controller.

I can configure the lightbar as follows:

- Instead of a single alley light on the side of the lightbar, the entire corner of the lightbar can steady burn white to provide incredible alley lighting.
- Intense takedown lighting in the front with multiple modules configurable as takedowns.
- Option to have full front scene lighting.

- Door-Kill function will shut off the corner module of the lightbar when the officer opens his/her door allowing for traffic to see the officer and the officer not be blinded by the lightbar
- Rear of lightbar can flash emergency colors and switch to an all amber traffic advisor.
- Low-Power intensity mode for night time use

The nForce Series perimeter lighting can be configured as follows:

- Pushbar lights can flash emergency colors and steady burn white when either Takedown or Scene mode is selected
- Intersection lights on the push bumper and doors can flash emergency colors and steady burn white when alleys are selected.
- Rear Deck Lights can steady burn white when the vehicle is put into reverse to allow for more rear lighting.
